Overview of TFRI Network Meeting ...... Kathy Yeager and Dan Fitzgerald

- Kathy gave an overview of the Cessation Workgroup presentation at the Network Meeting on November 3<sup>rd</sup>.
  - o Structure and intended Goals/Outcomes of the workgroup were endorsed
- Debrief of major action items at the Network Meeting
  - o Dan provided an overview of the meeting and endorsed action items
    - Policy Priorities
      - Increase Local Tobacco Retail Licensing and Point of Sale Restrictions
      - Increasing the minimum tobacco sale age from 18 to 21
      - Increasing funding for the tobacco control program to fund comprehensive tobacco control programing including of cessation services, prevention initiatives, etc.
    - Formation of a Steering Committee
      - Each workgroup will have Co-Chairs to represent both community and state-level perspectives
      - For this workgroup Kathy and Carolyn are serving as the Co-Chairs

- RI Cessation Council has not met since last TFRI Cessation Workgroup Meeting
- Previous discussions were had around the term "cessation" versus "treatment" in the naming of the workgroup and council. Carolyn explained that the verdict was to keep "Cessation" as it was encompassing of treatment, training, etc.
